I/We understand that I/we will be responsible to reimburse Native People of Sudbury Development Corporation all fees associated with Non-sufficient Fund charges if they occur.

I/We may cancel this PAD Agreement at any time, subject to providing written notice to Native People of Sudbury Development Corporation at the address provided below. This notification must be received at least 10 business days before the next debit is scheduled. I/We may obtain a sample cancellation form, or more information on my/our right to cancel a PAD Agreement at my/our financial institution or by visiting www.cdnpay.ca

I have certain recourse rights if any debit does not comply with this PAD Agreement. For example, I have the right to receive reimbursement for any debit that is not authorized or is not consistent with this PAD Agreement.
